I further agree that, in the event of default, the unpaid balance and finance charges shall become immediately due and payable without notice or demand. Until the unpaid balance and finance charge has been paid, I agree that title to and right of possession of the goods shall remain in you; and I will not sell, remove, or encumber them without your written consent, and that I assume responsibility for any loss or damage. I agree that, subject to the consent of Woodcredit, Inc. dba TimberKing, may add further purchases to this account and that such additions may change the sum of my monthly payments and/or the number of remaining payments due. Further, I hereby grant to Woodcredit, Inc. dba TimberKing, a security interest in any additional goods and services purchased and added to this account.
